ALL horse stalls and VIP tables must be pre-paid. All checks will be deposited immediately and credit cards will be processed immediately upon receipt by Show Secretary. If you wish to avoid credit card processing fees you can mail a check by US Mail before the pre-entry deadline to pay for stalls and VIP tables. Upon check in you may leave a check for the payment of the remaining fees, ie, classes, championships, office fee etc.

Shavings: NO OUTSIDE SHAVINGS PERMITTED. Any off site shavings will result in an additional \$25 clean up fee per stall.

A one time \$50 clean up fee per stall and/or tack room will be incurred for any left behind personal belongings and/or trash.

Class Scratches: Will be issued 50% refund if done the day before the class, scratches done on same day as class will be non-refundable. **NO EXCEPTIONS!**

100% refund of entry fees issued with Vet Certificate only. Horses will not be able to compete once Vet Certificate is received.

Refunds will be issued within 30 days from last day of show.

Stalls may only be transferred from one owner to another if all stalls are sold out. Upon receipt & approval of transfer request form (available at show office), person receiving stall will be charged full stall fee & person transferring stall will receive refund minus a \$50 handling fee.

Warm up Ring: Only Horse, Rider & Handler will be allowed. **NO EXCEPTIONS!**

Inspections: Before entering the arena, all Exhibitors will be asked to go through a check in area and their horse will be inspected by the Inspection Farrier, Inspection Vet and Show Steward. All exhibitors will come with their horse tacked up but with bit in hand for Steward inspection. Only the bit that is inspected will be allowed in the holding area. Once in holding area, if bit needs to be changed, the Exhibitor and horse must go to the steward and obtain permission to change the bit. All horses placing first, second, and third must step into check out area upon exiting arena where they will be asked to drop the horses bit for inspection by the steward and may also be subject to random drug testing. **NO SPURS PERMITTED IN HOLDING AREA. Horse tack is to be competition ready for the class showing. No training equipment of any kind will be allowed in the holding area, this includes additional bits, draw reins, etc. Bags/pails will be inspected. The Inspection Farrier will be checking for lameness**

and the legality of shoes. Trainer, Owner or Exhibitor may assist in lifting feet. Any horse refusing to have all four hooves inspected will NOT be allowed to compete. **NO EXCEPTIONS!** Exhibitors shall be familiar with the rules prohibiting soreing as per Paso Fino Horse Association rules, Chapter two, IV, Paragraph E; and with rules concerning shoeing as per Paso Fino Horse Association rules, Chapter two, IV, Paragraph C.

PARKING: Horse trailer parking is NOT permitted in barn area. Horse trailers MUST be parked in designated trailer parking areas. Absolutely NO trailers, cars or trucks parked between Barn Y and Main Arena 5 entrance. **ONLY** golf carts will be permitted in this area, between barn Y and main arena 5.

CLASS CALLS: Every effort will be made to maintain a working PA system. However, due to unforeseen problems with any mechanical device, the PA system and paddock calls must be considered a courtesy. It is the responsibility of the exhibitor to be sure that his/her horse is at the gate 30 minutes prior to the start of their class.

DOGS ON COMPETITION GROUNDS: Dogs MUST be on a leash at all times on showgrounds.

MOTORIZED VEHICLE STATEMENT: Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to , golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a

minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

DAMAGE: World Equestrian Center hold individual owners and exhibitors responsible for damages incurred by them, or their agents, to barns or other properties on the showgrounds and will bill them accordingly. Ocala PFHA, Ocala Cup International and/ or Show Management will in no way be responsible for any loss/ damage that may occur. It will be a condition of entry that each exhibitor shall hold the horse show, its management and World Equestrian Center blameless for any loss or accident to his/her horse(s) or equipment that may occur from sickness, fire or otherwise. Ocala PFHA, Ocala Cup International Show, World Equestrian Center will not be responsible for injuries sustained in any way to exhibitors, spectators, employees or any other interested parties.

SHOW RULES & IMPORTANT INFORMATION

- **It is important to OPFHA that everyone in our shows has the best experience possible. If you have any needs which we could address in advance to make your experience better, please contact Felicia Morejon at 305-916-8609. If you have any ADA accessibility issues, you can reach the show facility at (352)414-7900. Please include with entry if you have any mobility issues requiring parking close to stalls or arena.**
- **ALL fees must be paid & paperwork completed before exhibitor back numbers are released.**
 - **4% credit card processing fee added to all credit card transactions.**
 - **ALL horses will be charged a stall fee. NO grounds fees available. 100% refund will be issued for class entry fees with vet certificate after 11/19/22. Horses that submit a certificate in order to receive a refund will not be allowed to show in this event.**
 - **\$100.00 handling fee will be charged for all returned checks/declined credit cards.**

If show bill is not paid in full , returned check or declined credit card is not paid in full within 2 weeks after notification, PFHA will be immediately notified of the non-compliance!

PLEASE READ ALL FEES ASSOCIATED TO SHOW!

●**ALL exhibitors must enter the arena when called by gatekeeper. It is your responsibility to be in warm up arena 30 minutes before your class! Barn calls are a courtesy!**

●**Show Arena will close 2.5 hours after show ends. Lights in the barns will be dimmed 3 hours after show ends. Horses can train in outdoor covered warm up arena that is adjacent to Arena 5 , 24 hours a day. NO loud music in the barns!**

●**Show Management reserves the right to combine classes if less than 3 entries in a class.**

●SHOW MANAGEMENT RESERVES THE RIGHT TO REFUSE ENTRIES.

●**Exhibitors are notified that any act of discourtesy or disobedience to the judges, officials or show staff, on the part of the owner, manager, rider, or groom shall disqualify the horse, and the owner shall forfeit his entry fee, other fees and may be asked to leave showgrounds.**

AWARDS:

Ribbons will be awarded to the 1st-6th place in class. Championship Ribbons will be awarded to the 1st – 4th place in the Championship Class.
